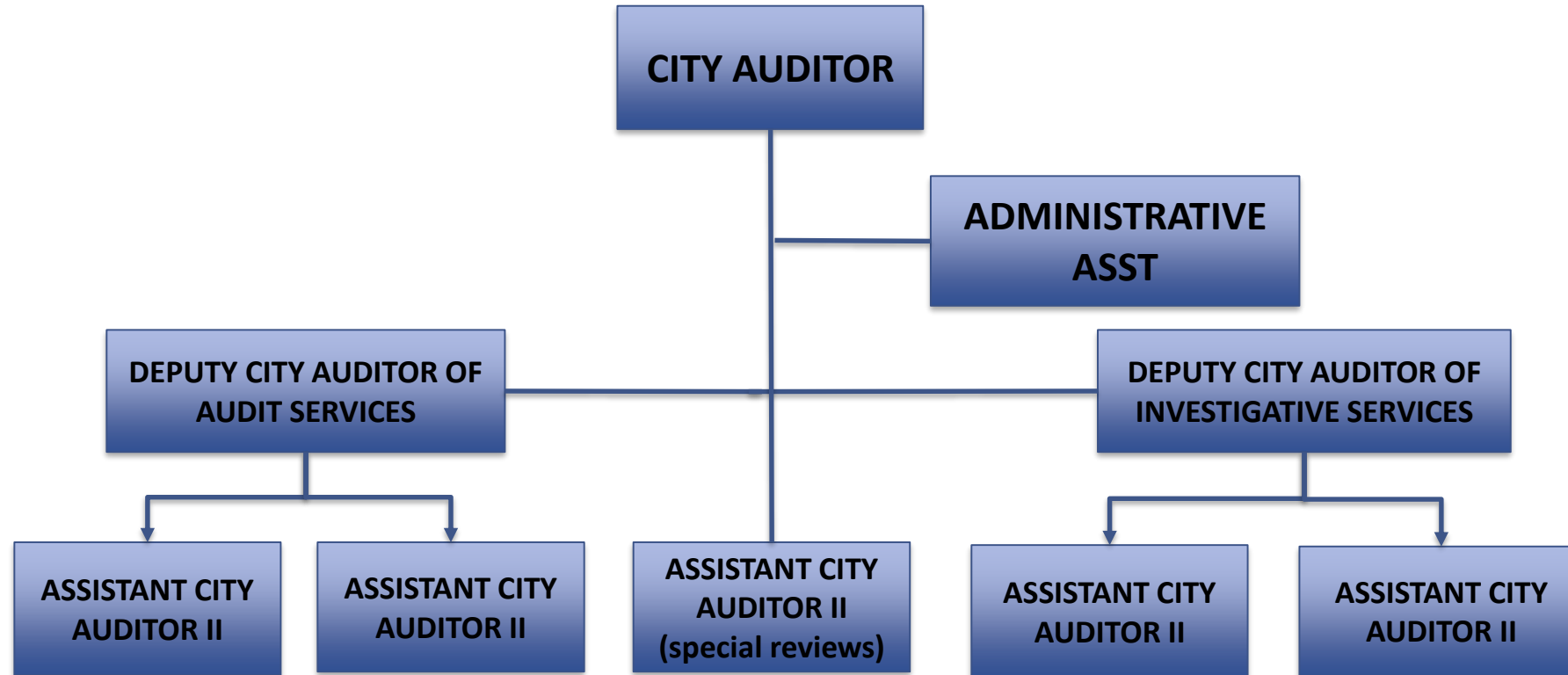
# PURPOSE OF THE ANNUAL WORK PLAN
