

BE IT ORDAINED by the Council of the City of Norfolk:

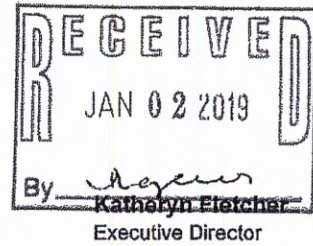
