V. Matters of the Chair

- A. Approve minutes from April 21, 2025

- a. A motion was made by Dr. Carroll to approve the minutes, Jazmine Garcia seconded, and it was approved.

- B. Homelessness in the city, camps, tents, panhandling, how to advocate

- a. What is the ordinance, and do we need neighborhood services to provide services? The outreach services team moves through the city each day to offer services. Let your groups know that the city offers a variety of services for the unsheltered population and if you talk up the efforts, that would be helpful. When we go to the action meetings and civic leagues, let them know that the city provides housing resources as well, not just the CSB.

- C. Tiny homes

- a. These homes were purchased but not property for them. Besides the homes, there is sewer and water to consider, and we do not have a place for them in this area. At the time of purchase, it was a good thought, but leadership began to see what the next step was and we had to pivot. Dr. Woodard stated that the board could advocate for all the things that we do at the CSB, which in turn helps with the homeless' issues. The City Manager and Leadership are on board with what we do here at the CSB 100%.

IV. Matters of the Executive Director (Dr. Nathan Woodard)

Review/approve the Strategic Plan 2025-2028

- a. This is a living document, and it will be revisited monthly by the Executive Team to see what needs to be amended. Dr. Vaughan recommended that we approve the plan, Dr. Carroll made a motion, and Jazmine Garcia seconded, and it was approved.

- a. Sandi presented about the ITCN.

- a. Dr. Woodard spoke to the hiring fair and reported that we had 33 offers. Dr. Carroll will let her cohorts know they can push their interns to the CSB.
