Norfolk is the first city in Hampton Roads to launch a diversity, equity and inclusion initiative.







Americans with Disabilities Act (ADA)

The Americans with Disabilities Act (ADA) is a law that protects people with disabilities from unfair treatment.

The ADA gives people with disabilities the same right to employment opportunities, purchasing choices, and participation in state and local government programs as everyone else.





ADA Requirements

Title II of the ADA requires the City of Norfolk to review its programs, policies, and activities for compliance. This is called an **ADA Self-Evaluation**.




More ADA Requirements

If the ADA Self-Evaluation shows barriers to access, the City of Norfolk must develop a **Transition Plan** that:

- Identifies the barriers,
- Lists the actions the city will take to get rid of them,
- Includes a timeline with costs, and
- Says who will manage the work.

Community Benefits

1. Easier access to city services for everyone
2. More transparent decision-making
3. Better collaboration between the city and people with disabilities
4. Encourages responsibility and awareness of risks.



Community Voice – Round 1

Define Success:

What does an accessible Norfolk look and feel like?

Think about:

- Physical access (buildings, sidewalks, transportation)
- Communication (language, signage, technology)
- Emotional experience (feeling welcome, safe, independent)

Community Voice – Round 2

Find innovative solutions:

What accessibility solutions should Norfolk consider?

Please include:

- The name or description of the solution
- Where it was (city, state, country, or organization)
- Why it stood out or worked well

Community Voice – Round 3

Prioritize improvements and fixes:

Which accessibility changes matter most right now, and why?

Try to include:

- A specific improvement or fix (e.g., curb cuts, signage, website accessibility, staff training)
- A reason it should be prioritized (e.g., safety, high usage, equity, legal compliance, personal experience)

Community Voice – Round 4

Maintain progress:

How can we improve access without adding new barriers?

Think about:

- Rules that might keep progress on track
- Ways to plan for accessibility from the start
- Barriers we can prevent with better designs, training or communication

Community Voice – Round 5

Spread the word:

How can we help people learn about accessibility in Norfolk?

Possibilities include:

- Social media, storytelling, or community events
- Partnerships with schools, businesses, or faith groups
- Creative ways to make accessibility visible and valued
