

Applying for a Hauling Permit?

Types of oversize/overweight/over height hauling permits:

- Single trip permits one trip, one-way; a faxed copy is valid for vehicle
- Blanket (Annual) Permits hauler must have original (city seal) in vehicle; must have original (pink seal) in vehicle. These permits are also processed by DMV; select "Norfolk" as a destination).
- Restricted Annual Permit issued when vehicle dimensions are outside of regular annual dimensions and a specific route is designated for vehicle movement within the City of Norfolk
- Exception Permission to travel on a time restricted roadway

Apply:

Please apply and pay online at: https://citizen.norfolk.permitcity.com

Processing time: same day (7 days per week)

or include the following with the attached application:

- A copy of the DMV/VDOT permit page showing dimensions
- A copy of liability insurance (\$500,000.00 minimum)
- Processing time (2 to 3 business days)

Cost:

Single Trip: \$75.00

Annual Permit: \$300.00 – valid for one year starting on the date issued.

Restricted Annual Permit: \$300.00

Payment Methods:

- Pay online as part of the online permit process. There is a small convenience fee between \$1 to \$3 dollars depending on the permit.
- If applying by other means, we accept Visa, Master Card, and Checks (not TELECHECK) Please indicate on application. We will then contact you when permit is ready for card information. PLEASE DO NOT WRITE CREDIT CARD NUMBER ON THE APPLICATION FORM.
- If paying by check, the check must be received prior to the issuance of the permit.
