PLEASE TAKE NOTICE that the Council of the City of Norfolk will hold the following meetings on **TUESDAY, JUNE 22, 2021**, in the City Hall Building, 810 Union Street:

This meeting is being held by electronic communication means pursuant to Item 4-0.01 in House Bill 30 (Chapter 1289) of the 2020 Session.

The Governor of the Commonwealth of Virginia has declared a State of Emergency due to the public health danger of the novel coronavirus COVID-19 pandemic, which constitutes a disaster and emergency under Virginia Code Section 44-146.16.

The COVID-19 pandemic makes it impracticable or unsafe for the City Council to assemble in a single location.

The purpose of this meeting is to discuss or transact the business statutorily required or necessary to continue operations of this public body and the discharge of its lawful purposes, duties, and responsibilities.

This meeting will be conducted by the following electronic communication means: telephonically and electronically through WebEx.

There will be no public comment at the Joint meeting or informal meeting.

Comments at the formal meeting will be limited to agenda items only and accepted by the Clerk's Office by **3:00 p.m. the day of the hearing**.

The formal meeting will not include a "new business" session.
