



# The Waste Management Guide to Scheduling Collections

# Normal Collection

## No Scheduling Required

**90-Gallon Green Refuse Container - Lids must be closed and not placed behind vehicles, so the container can be retrieved.**

- Bagged food and household waste
  - \*Bagging waste helps to reduce litter!*

- Small household items/ appliances
- Small electronics

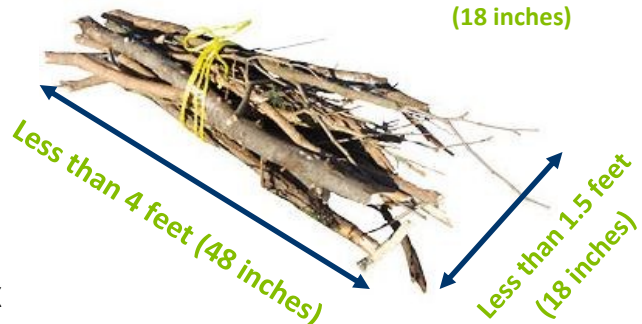
*\*ONLY alkaline batteries can be placed in the 90-gallon can*

- Never place construction materials in the 90-gallon can



### Yard Waste

- Maximum 20 clear bags of yard waste only
- Maximum 20 tied bundles, less than 18 inches in diameter
- Combination of 20 clear bags or bundles
- Individual branches/ limbs, less than four (4) feet in length and less than six (6) inches in diameter
- Yard waste can also be placed in an uncovered, 30-gallon or less, plastic or metal container



## Special Collections

### These Items MUST be Scheduled

**Overflow**—These are items that are too large to fit inside the 90-gallon refuse container. These are also items that will damage the blades on refuse vehicles, if not set out separately from the 90-gallon refuse container.

- Items under 75 pounds
- Lightweight furniture less than 25 pounds
- Large/excessive cardboard, flattened and tied in bundles not to exceed four (4) feet long, by one-and-a-half (1.5) feet wide and three (3) feet high.



- Mirrors—must be wrapped to prevent spillage, if broken
- Toys

## Special Collections Continued

### These Items MUST be Scheduled

**Bulk Waste—There is a three (3) cubic yard limit, per collection. Charges may apply for waste that exceeds this limit.**



- Appliances—Taping or removing refrigerator doors is advised, for the safety of children.
- Basketball Goal
- Bicycles/Lumber/Decking Material (Non-contractor generated waste)
- Cabinets
- Carpet (rolled) and Padding
- Dog/Cat House
- Doors
- Exercise Equipment
- Fencing (wooden, vinyl, chain link—NO concrete attached)
- Furniture
- Grills (NO Propane tanks)
- Hot Tub
- Ladders
- Lawn Chairs
- Lawn Mowers (NO gas)
- Lumber/Wood boards and pieces
- Mattress and Box Springs, Bed Rails
- Outdoor Furniture, Picnic Table
- Pallets
- Passenger tires, NO rims (limit of four (4) tires per collection day; maximum of twelve (12) tires per year)
- Pool Cover/Ladder/Pump
- Pool Table/Ping-Pong Table
- Shelving Units/ Filing Cabinets
- Televisions (Glass must be secured to prevent spillage)
- Toilet/ Tub
- Windows/ Mirrors, wrapped (Glass MUST be secured to prevent spillage)
- Yard Waste/ Limbs

## Waste Management does not collect Household Hazardous Waste

- A/C Refrigerants
- Antifreeze
- Automotive Batteries
- Batteries (Ni-Cd, Ni-MH, Li-ion)
- Bleach
- Carburetor & Fuel Injector Cleaners
- Chemicals
- Cooking Oil
- Degreasers
- Drain Cleaners
- Fertilizer
- Fuel Additives
- Gasoline/Diesel Fuel
- Herbicides
- Insecticides
- Kerosene
- Mercury Thermostats/ Thermostats
- Motor Oil
- Oven Cleaners
- Paint/ Thinners/ Turpentine/ Removers/ Sealers
- Pesticides
- Photographic Chemicals
- Pool/ Hot Tub Chemicals
- Propane Tanks/ Cylinders
- Solvents
- Wood Preservatives/ Fungicides



**These items are accepted at SPSA's Norfolk Transfer Station, located at 3136 Woodland Avenue, every Tuesday and Saturday from noon until 4:00 p.m.**

## Waste Management and SPSA NEVER Accept

- Bricks, Concrete and Dirt—These items must be collected by a private contractor
