AN ORDINANCE AMENDING THE FY2021 ANNUAL APPROPRIATIONS ORDINANCE (NO. 47,999) SO AS TO ACCEPT, APPROPRIATE AND AUTHORIZE THE EXPENDITURE OF GRANT FUNDS UP TO THE SUM OF \$16,153.00 FROM THE VIRGINIA DEPARTMENT OF EMERGENCY MANAGEMENT THROUGH ITS STATE HOMELAND SECURITY GRANT FOR THE NORFOLK COMMUNITY EMERGENCY RESPONSE TEAM PROGRAM.

BE IT ORDAINED by the Council of the City of Norfolk:

Section 1:- That the FY2021 annual appropriations ordinance (No. 47,999) is amended and reordained so as to revise Section 14 to add subparagraph (nnn) in its entirety to read as follows:

(nnn) That, if and when made available from the Virginia Department of Emergency Management, the sum of up to sixteen thousand one hundred fifty three and xx/100 dollars (\$16,153.00) is hereby appropriated and authorized for expenditure for the Norfolk Community Emergency Response Team program.

Section 2:- That this ordinance shall be in effect from and after the date of its adoption.
