Mr. Martin informed the Board that it was time to elect a Chairperson and a Vice-Chairperson. Ms. Calliott made a motion to nominate Frederick V. Martin for Chairperson. This motion was seconded by Dr. Hopkins and approved unanimously by the Board. Ms. Calliott made a motion to nominate Mr. Steven G. de Mik for Vice-Chairperson. This motion was seconded by Mr. Neikirk and approved unanimously by the Board.

Dr. Hopkins raised the question of why the City Council has not filled the remaining three Board vacancies. After considerable discussion, Dr. Hopkins made a motion that the Chair writes a letter on behalf of the Board to the City Council requesting that the three vacancies be filled. This motion was seconded by Ms. Calliott and approved by the Board. Mr. Martin informed the Board that of the three vacancies, one of those should be filled by a citizen from the financial district. Mr. Martin asked Mr. Wilder to get an opinion from the City Attorney regarding “banking/investment” appointees and distribute opinion to Board members.

There being no further business, the meeting was adjourned at 3:03 p.m.
