### **Committee Reports**

#### **Administration and Planning:**

There was no meeting.

#### **Investment Management:**

Mr. Neikirk informed the Board that the Investment Committee did meet today at 11:00 a.m. Eric Ralph and Roger Brown with Summit participated by way of conference call.

The Committee discussed the allocation status of the fund. Total assets were at approximately \$760 million at the end of May which is roughly about 74% funded

based on our prior calculated liability. The TIPS funding was completed in May, and we now have approximately \$40 million invested in this fund.

The Committee heard the continuation of Public and Private Core Real Estate Opportunities presentation from Summit. As a result the Committee has decided to invite JP Morgan and UBS to come and make a presentation to the Investment Committee on July 14, 2010 beginning at 10:30 a.m.

The Chair, Ms. Calliott, was not at the previous meeting where a retiree came to dispute the Board's decision on ordinary disability, asked had anything transpired since the last meeting. Mary Lou Nexsen responded by saying that Sara Jones has since contacted Ted Wilder by telephone. She has received the formal letter from the Retirement Office as to the Board's decision to not comply with her request and she is not happy. Her next step would be to take this to court. The City Attorney's office would represent the Board.

Ted Wilder announced to the Board that the Employees' Retirement System received the Government Finance Officers Association Certificate of Achievement for Excellence in Financial Reporting Award for the Fiscal Year Ended June 30, 2009.

Mary Lou Nexsen informed the Board that Brian Hallman will appeal to the Board to consider whether he was eligible to port (or transfer) his City of Norfolk Retirement System credit to the Virginia Retirement System. The Trustees decided to neither amend the agreement between both parties nor make an exception to the terms and conditions of the agreement. The Trustees also determined that it was important to keep the policy fair and consistent for all employees. Mr. Hallman has notified Mrs. Nexsen that he is appealing and will be scheduled to state his position at the August 11, 2010 meeting.

The Board's next meeting is on Wednesday, July 14, 2010 at 12:00 noon. The Investment Committee meeting will begin at 10:30 a.m.

There being no further business, the meeting adjourned at 1:03 p.m.
