The Chair asked that the Trustees consider asking staff to order box lunches. This will be cost effective and there would be less food left over. The members agreed that going forward box lunches would be ordered.

Committee Reports

Administration and Planning:

Mr. Hill reported that the Committee did not have a meeting.

Investment Management:

Mr. Neikirk reported that the Committee did not have a meeting. Mr. Neikirk did report that the total fund was \$852.5 million as of January 31, 2011. The actuarial liability is \$1.047 billion. The estimated funding status is approximately 81%. The total fund composite was 1.34%. The equity composite was 1.72%, fixed income .66%, and international .96%. The outperformance was added by the active management in the fixed income portfolio (PIMCO). TIPS is in line with the benchmark at .20%.

Once the System funds real estate the Pension System's allocation will be:

5%	Real Estate	36%	Equity
35%	Fixed Income	24%	International Equity

JP Morgan has notified the System that they are in the process of sending a Capital Call Notice. When staff receives the Capital Call Notice, \$19 million will be transferred from the PIMCO account.

The Trustees were provided PIMCO's Quarterly Investment Report as information.

The Chair had asked Ted and Myrella to survey other systems throughout the State of Virginia on any discussion of plan changes. Survey responses were provided to the Trustees.

Mr. Wilder informed the Trustees that the Association of Municipal Retirement Systems (AMRS-VA) meets in the spring and fall yearly. The City of Roanoke will be hosting the fall meeting. This year's fall meeting includes a Trustee Training session. Roanoke circulated two dates for consideration by association members:

Roanoke is trying to get a preliminary number of how many trustees may be interested before negotiating rooms at the Hotel Roanoke. The next Retirement Board meeting is scheduled for March 9, 2011 at noon. There will not be an Investment Committee meeting.
