There are a total of 18 disability retirees up for reexamination. One is suspended due to not submitting the required information; 5 have pending paperwork; one is due effective 9/1/15. Eleven are not due at this time.

L. Committee Reports

Investment Management:

Mr. Neikirk reported that there was an Investment Management Committee meeting at 11:00 a.m.

Summit presented an equity allocation review and follow up discussion on the asset liability study. Generally, Summit's material pointed out that the MSCI ACWI ex-US allocation is somewhat deficient in developed small cap equities which other international investors tend to hold while the index does not. Summit will send a pie chart of a global index that includes developed small cap so we can see what the total global portfolio looks like. They had a section on passive vs. active management. Summit does not believe there is a lot of opportunity for excess return in domestic large cap equity. They do feel there are opportunities for active excess return in small cap U.S. equities and international equities, especially when you decouple the emerging markets.

Summit discussed PIMCO's fee. Summit estimated that the special one-year fee was a benefit to the Plan, saving anywhere from \$24,000 and \$75,000 over the course of the year. They expect that the PIMCO performance was up 20 basis points year-to-date.

A review of the Plan indicates assets dropped to \$966 million as of August 31, 2015. Based on the July 2014 liability valuation results in about an 81 percent funded level. The asset allocations were within their stated ranges.

Administration and Planning:

There was not an Administration and Planning Committee meeting. Ms. Garczynski stated she anticipates have a meeting later during the month. Ms. Nexsen requested to be included in the meeting.
