 Approximately \$11.5 million will be transferred from MLPs to the UBS Trumbull Property Fund, which currently has less NERS funds invested than the JP Morgan Real Estate account; after the transfer both accounts will be approximately equal.

Other Topics:

The Board heard a presentation from Ann Sullivan, legal counsel for Mr. Timothy Carey, regarding his portability request to transfer his years of service with VRS into NERS. Mr. Carey submitted his request

for transfer in August 2015, the transfer was subsequently reversed when it was discovered that the request was made after the 18 month eligibility window. Ms. Sullivan presented materials in support of the claim that a since-rescinded Amendment to the Portability Agreement in effect at the time of Mr. Carey's request did not call for an 18 month eligibility window. She therefore requested that Mr. Carey's service be transferred from VRS to NERS. Ms. Sullivan noted that the Amendment was rescinded in March 2016 and that she thought that it was rescinded because of Mr. Carey's portability application. Ms. Sullivan also raised the following concerns regarding the handling of Mr. Carey's transfer request: member not properly notified of amendment; City communication duties of transfer of rights, the City website at the time of the transfer request did not contain Portability information, and the rescission of the transfer has prohibited Mr. Carey's ability to apply for a Normal Service Retirement. Ms. Sullivan requested, in light of presented materials, that the Board approve Mr. Carey's transfer request.

With a quorum established, a motion was made, seconded and approved that the Board assemble in an executive session pursuant to Virginia Code Section 2.2-3711A(7) for the discussion of personnel/legal matter, specifically:

For consultation with legal counsel and briefing by staff members pertaining to probable litigation and consultation with legal counsel employed or retained by the public body regarding specific legal matters requiring the provision of legal advice by such counsel.

At the conclusion of the closed session, the Board adopted the following Resolution:

A RESOLUTION CERTIFYING A CLOSED MEETING OF THE BOARD OF TRUSTEES OF THE NORFOLK EMPLOYEES' RETIREMENT SYSTEM IN ACCORDANCE WITH THE PROVISIONS OF THE VIRGINIA FREEDOM OF INFORMATION ACT.

WHEREAS, the Board of trustees of the Norfolk Employees' Retirement System convened a closed meeting on this date pursuant to an affirmative recorded vote and in accordance with the provisions of the Virginia Freedom of Information Act for the consideration, advice and discussion of a legal matter pursuant to Virginia code Section 2.2-3711A(7); and

WHEREAS, Virginia Code Section 2.2-3712 requires a certification of this Board of Trustees that such closed meeting was conducted in conformity with Virginia law; now, therefore,

BE IT RESOLVED by the Board of Trustees of the Norfolk Employees' Retirement System:

Section 1:- That the Board of Trustees hereby certifies that, to the best of each member's knowledge, (i) only public business matters lawfully exempted from open meeting requirements by Virginia law were discussed in the closed meeting to which this certification resolution applies, and (ii) only such public business matters as were identified in the motion convening the closed meeting were heard, discussed or considered by the Board of Trustees.

Section 2:- That this Resolution shall be in effect from and after its adoption.

After the Board reconvened in open session, Mr. Neikirk put to a motion which was seconded by Ms. Yvonne T. Allmond and the Board approved, the following response to the presentation made by Ms. Ann Sullivan on behalf of Mr. Timothy Carey:

In order that there is a formula to calculate the assets to transfer from VRS to NERS, Mr. Carey would have had to make his request to transfer his VRS assets either on or before July 19, 2000, which was within 18 months, as a vested VRS member, after becoming a NERS member on January 19, 1999 under

the May 7, 2015 amendment or on or before July 19, 2005, which was within 18 months as a vested NERS member as of January 19, 2004, under the June 19, 2000 agreement. Mr. Carey did not make his portability asset transfer request until August 18, 2015, which was past the required request deadlines for asset transfer under either the 2000 agreement or the 2015 amendment. Regardless of which agreement or amendment is applied, Mr. Carey did not meet the asset transfer request timeframes deadlines applicable to the order of portability.
