

TOLER PLACE/WILLOUGHBY BEACH EROSION SAND REPLACEMENT

LOCATION

5 Blocks of Willoughby Beach, from 11th View St. to western end at the terminal groin. The terminal groin is the area, comprised of rocks, that extends into the water that helps prevent erosion.

PROJECT INFORMATION

Due to higher-than-normal high tides, the dunes and beach between 11th View St. and 12th View St. have been severely eroded. Approximately 20,000 cubic yards (CY) of sand will be removed from the western end of the beach near the terminal groin and from between 14th View St. and 15th View St., hauled to Toler Pl. and placed to rebuild the dunes and provide additional protection.

SCOPE OF WORK

- Remove sand from approximately 180 linear feet (LF) at terminal groin and approximately 800 LF between 14th View St. and 15th View St., haul to Toler Pl.
- Grade borrow area to smooth gradual slope and grade fill area of approximately 775 LF to repair dunes.
- Plant repaired dunes for stabilization.

CONSTRUCTION IMPACTS

- Willoughby Beach will be closed Monday through Friday, from 7:00 am until 5:00 pm between 11th View St. and the western end at the terminal groin. Beach visitors are asked to access the beach at 11th View St. or other eastern access ways. The beach will be open on weekends and evenings.
- Starting on May 27, 2025, Willoughby Beach will be closed Monday through Friday, from 7:00 am until 5:00 pm between 11th View St. and the western end at the terminal groin. The beach will be reopened every evening for public use after 5:00 PM. Beach visitors are asked to access the beach at 11th View St. or other eastern access ways during working hours. The beach will be open every weekend and Holidays, including Thursday, June 19th through the following weekend and July 4th through the following weekend.
